## RETURN POLICY

The purchaser has 180 days to return a product from the date in which the order was placed. To be eligible for return, product must be in the same condition which it was received. Purchaser is required to complete a Return Merchandise Authorization (RMA) form found in the channel portal of the Horner Lighting website at [www.HornerLighting.com](http://www.HornerLighting.com) to begin the return process.

Once Horner Lighting receives an eligible item for return, it will be inspected and the purchaser notified that the product has been received. Horner Lighting will notify the purchaser on the status of the product after inspecting the item.

If the return is approved, Horner Lighting will initiate a refund to the purchaser's original method of payment. The credit and/or funds will be received by the purchaser within 6-8 weeks depending on the purchaser's merchant refund policies.

Purchaser will be responsible for any and all shipping costs associated with the return process. Shipping costs are non-refundable. If the purchaser receives a refund, the cost of shipping will be deducted from associated refund.
